All of us at AEGEAN try every day to serve you in the best possible way, prioritizing your safety.

However, given the dynamically changing situation, we have been forced to adapt our flight project throughout this period in accordance with the restrictive measures imposed by the competent authorities, which monitor the epidemiological data.
Today, as travel within Europe is allowed again and strict restrictions are lifted, we are happy to be able to expand our network and reconnect Greece with Europe and Europe with Greece. From June 15, we begin to bring additional destinations back to our schedule, and we will continue to gradually increase your options to bring you back to your favorite places. In this new beginning, however, we must ensure together that each of our travels protects the health of all. So, in addition to the extensive safety and hygiene measures we have already implemented, you should also be aware of each country's regulations on entry, transit and residence requirements.

To help you plan your next trip with more confidence, here are some key points from the recent restrictions imposed by the Greek government on arrivals in Greece, valid from June 15 to June 30, 2020.

Passengers are categorized into two groups depending on the country from which they come to Greece:

Group A: Austria, Bulgaria, Germany, Denmark, Switzerland, Estonia, Ireland, Iceland, Croatia, Cyprus, Latvia, Lichtenstein, Luxembourg, Malta, Norway, Thailand, Hungary, Hungary, Poland, Rhodes.

Group B: Albania, Belgium, France, Italy, Northern Macedonia, the Netherlands, Portugal, Spain, Sweden, other countries outside the European Union.

Passengers arriving at Athens International Airport from a Group A country will be screened for COVID-19 upon arrival. - Passengers arriving at Athens International Airport from a Group B country, either by direct flight or by Group A country, will be required to undergo diagnostic tests for COVID-19 upon arrival. - Passengers arriving at Thessaloniki Airport "Macedonia" will be required to undergo diagnostic tests for COVID-19. All passengers will be given a Passenger Information Form during Check in or Flight, which they will need to fill out and deliver to the Authorities upon arrival.

Passengers who have undergone a diagnostic test for COVID-19 are required to remain self-limiting for 24 hours at the address they will declare, until the results are announced.

Passengers with flight responses via Athens or Thessaloniki will undergo a diagnostic test for Covid-19 at these airports. However, they will be able to continue their journey to their final destination where they will be self-limiting until the results of the diagnostic test are announced. In addition, by decision of the Greek Government, the ban on flights to / from the United Kingdom and Turkey is extended until 29.06.2020.
